Access to civil justice is of paramount importance for enforcing citizens' rights. At the heart access to civil justice lies litigation funding and cost management. Yet, over the past decades, access to justice has been increasingly put under pressure due to retrenching governments, high costs of procedure, and inefficiency of courts and justice systems. Within this context, the funding of litigation in Europe seems to be shifting from public to private sources. Private actors and innovative business models have emerged to provide new solutions to the old problem of financial barriers to access to justice.

With the participation of policymakers, practitioners, academics and representatives of civil society from all over Europe and beyond, the conference seeks to delve deeper into the financial implications of access to justice and the different ways to achieve sustainable civil justice systems in Europe.

The topics addressed in this international academic conference include different methods of financing dispute resolution and regulating costs, such as third-party funding, crowdfunding, blockchain technologies, public interest litigation, developments in ADR/ODR, new business models of legal professionals as well as law and economics perspectives on litigation funding.

#### **Panel 1: Emerging Trends in Litigation Funding: Crowdfunding, Third-Party Funding, and Beyond**

This panel delves into the multifaceted landscape of litigation funding. Esteemed scholars and industry experts will engage in a comprehensive exploration of the latest developments and emerging trends in litigation funding. This includes a dedicated focus on the impact of third-party funding and other

innovative financial models within the legal landscape. The discussion will encompass an assessment of the advantages, challenges, and potential risks associated with these alternative funding avenues. This panel seeks to stimulate an expansive dialogue about the broader implications of litigation funding. This panel solidifies the foundation of the conference, offering a vital platform for the analysis of litigation funding's potential to drive transformative outcomes across different legal contexts.

### **Panel 2: Debate: Altruistic Ventures: Balancing Profitability and Social Impact – Myth or Reality?**

This panel brings together a diverse group of stakeholders to delve into the difficulties of financing the costs of litigation in public interest cases. Associations advocating public interest causes and legal professionals as well as funders will engage in a thought-provoking dialogue surrounding the challenges and potential alternatives to promote access to justice for altruistic causes. The panel will explore the delicate balance between profitability and social impact, raising the critical question: Are altruistic ventures in litigation a mere myth or a tangible reality? Participants will share their experiences, insights, and perspectives on the struggles faced by representative associations, funding actors, and lawyers involved in public interest litigation. They will delve into the complexities of funding non-profit claims, the difficulties encountered in securing financial support, and the potential ethical considerations that arise when profitability and social impact intersect. The panel aims to foster a deeper understanding of the intricacies involved in financing public interest litigation and seek innovative solutions from the finance sector or more participatory practices like crowdfunding.

### **Panel 3: Young Scholars' Presentations**

As part of the conference's broader exploration of sustainable civil justice systems in Europe, this panel offers nuanced perspectives from emerging scholars. Following a call for papers, Early Career Researchers will present their work on financial innovations that facilitate collective litigation. The presentations will examine the implications of market-driven solutions designed to enhance consumer access to justice and highlight the strategic synergies between class actions and crowdfunding.

### **Panel 4: Current and Future Trends of ADR and ODR within the Modern Civil Justice System**

**Coordinated by Masood Ahmed** (Associate Professor Leicester University/Research fellow Vici project Erasmus School of Law)

Alternative dispute resolution (ADR) and Online Dispute Resolution (ODR) procedures are increasingly becoming a significant aspect of the modern civil justice landscape. They are viewed by policy makers and the judiciary as necessary means of controlling civil litigation costs and thereby promoting greater access to justice. Consequently, ADR and ODR procedures are being integrated within the traditional civil court process as well as forming part of online court procedures and systems. This panel will explore and critically discuss the latest developments and future trends of the role and impact of ADR and ODR procedures on civil litigation costs, access to justice and the future of the civil justice. The issues for discussion include: the latest developments and empirical data from the Online Civil Money Claims (OCMC) process from England and Wales on user experiences of mediation in the resolution of small money claims; the recent civil procedure reforms in Singapore which have introduced mandatory ADR for civil disputes; and the latest developments of ODR procedures within Europe.

## **Panel 5: Roundtable: Entrepreneurial Lawyering: Lawyers as Gatekeepers or Market Players?**

Entrepreneurial lawyering is the practice of law with a business-oriented approach. Lawyers leverage their legal expertise to provide innovative legal services to clients in various markets and jurisdictions. This can include utilizing new technologies to streamline legal processes (Legal tech start-ups), partnering with third-party funders, or accepting contingency fees. The panel will host a thought-provoking roundtable discussion on the evolving role of lawyers as market players. Legal experts and academics will explore the reasons and forms of the growing trend of entrepreneurial lawyering, its legal and ethical implications, as well as its economic perspectives. Topics addressed will include lawyers' strategies, portfolio management, business plans, and risk management. As the legal profession continues to evolve, it is crucial to understand these changing dynamics and their impact on the legal landscape and access to justice.
